## Who are Project Hope Horse Welfare Victoria?

Project Hope Horse Welfare Victoria Inc. (PHHWV) is a non-profit organisation committed to providing hope for Victorian equines through education, rehabilitation and advocacy. PHHWV Inc. is a registered incorporated non-profit organisation. It is governed by a committee of management. PHHWV is tax exempt and all donations over \$2 are tax deductible.

PHHWV is run by volunteers and is self funded though memberships, donations and fundraising.

### **PHHWV Missions & Goals**

- o Throughout Victoria, whenever and wherever possible:
- To assist owners through education, assistance and advice to rehabilitate their own horses
- o To provide emergency care, treatment and assistance to horses
- To rescue and rehabilitate any horse found abandoned, sick, injured or mistreated
- To find a suitable home for rehabilitated horses surrendered to PHHWV to, as far as possible, assures the horses' future well-being
- o To educate the community on the plight of neglected horses
- To contribute to the development of improved government legislation and policy

### Origins of Project Hope

PHHWV, originally known as Project Hope Horse Rescue first began in 1973 when a concerned Val Collingwood of Wallan, Victoria, wrote into RIDER magazine regarding the number of neglected horses in Australia.

She outlined a scheme whereby someone could co-ordinate the rescue and rehabilitation of these unfortunate animals and she suggested the name "Project Hope" in memory of a terribly neglected, supposedly aged, buck-jumper from Queensland. She had taken him home to try to save his life, giving him the name "Hope", although he had very little. He died three weeks later from massive worm infestation at the tender age of three. People responded to Val's letter, assuming that she was to be co-coordinator and the scheme became loosely organised on a district basis.

PHHWV grew until it became necessary to use newsletters for communication, to introduce memberships fees to help cover costs, and to draw up a constitution. With the help of a logo and media coverage, PHHWV became a familiar name in equine circles within Victoria.

Escalating calls for help made the year end busy - a 50% increase in calls, and widely varied locals worried for a horse, authorities 'Will you look after this horse?", and owners 'I cant cope, can you help me."

We helped more owners with practical help this year, whether a bag of feed, vet advice, or a straight talk about what looking after a horse means.

Nevertheless more horses have come into PHHWV care. It is at this point that effective, no-frills rehabilitation, and a well developed practice approach to handling neglected or abused horses, helps time and again to turn a fearful, shut down horse into a rideable horse or companion. To help us to talk about what we do, we prepared what is proving a valuable resource in 'Practice Notes' – what our experienced workers look for when visiting a reported horse, what they see as important steps in rehabilitation. We thank the experienced workers who have documented this.

Now in this fourth decade, we are thankful for the heritage of Project Hope in both enduring members and a record of past work. Someone comes forward willing to help a horse, or to fund a need, because of what they have known of Project Hope, what it has done in the past.

Thank you for the hands-on willingness of members, new and old, to care for horses in their own homes. We seek always to do better, and we look forward to change and to what new members bring.

Through Facebook, the web, face to face, and in print, we speak about horse welfare standards. Whether in post-racing futures for horses, in regard to saleyards, or Australia's brumbies, we rely on members' wide experience and input. We believe their broadly-based day to day experience with horses is a significant contribution.

## BUSHFIRE, DROUGHT & FLOOD

Members and friends of Project Hope, Triple R Equine Welfare, and Winged Horse bagged feed, summer rugs and consumables. A large truck delivered these with several hay rolls, to the SA equine groups in the Adelaide Hills.

A small return from Victorians to those who had helped us in earlier years, and well received.

# PROJECT HOPE HORSE WELFARE VICTORIA PHHWVV HORSE REPORTS

2014 has been a busy year, with a sharp spike in people seeking our assistance. All of the PHHWV Representatives have been hard at work! I take this opportunity to say a huge thank you to our Project Hope Reps for all of your hard work, in a year of cases with large numbers of equines and also of difficult cases.

The numbers of horses in reports have risen this year. Ten reports were of mobs varying from a minimum number of 10 horses up to nearly 40 in one ongoing report. The numbers of callers simply seeking advice also rose. This I think is wonderful, and in this members as well as reps and committee have been more than willing to pass on our personal knowledge in keeping our horse and pony friends happy and healthy! Another theme that stuck with me was the rise in requests from local councils about surrendering horses to Project Hope.

Finally, the numbers of unhandled or 'uncatchable' horses were also noticeable, alongside the unfortunately usual reports of underweight horses.

Thankfully Victoria has seen no disaster, major or minor. However it was still a dry spring and summer, which led to the inevitable reports of skinny horses.

# PROJECT HOPE HORSE WELFARE VICTORIA SHORT TERM CARE

2014 started with fifteen horses in short term care, including six newly acquired as a result of an RPSCA court action. Only three are still in rehabilitation or retraining, two from abused backgrounds. One is deceased. Six found a home after on the ground handling and retraining.

Twenty-five horses were surrendered during 2014. Eight needed significant veterinary attention, with both surgery work and home nursing care. We also had several surrenders of older stallions – even if they were only 3 feet high! Two groups were herds with older owners who realised their animals were being neglected - seven of these horses came into short-term care, three found local homes, and two were directly leased. Other horses were older thoroughbreds whose owners could not understand nor meet their care.

Lessees of seven PH horses asked if their horse could be rehomed; to date only two have come into short-term care.

Thirty-six members offered short-term care, three for several horses. Thank you to each one for opening their paddocks. They have given hours in treatment, in feeding programs and especially in handling to change behaviour and develop trust. They would say "We wouldn't be doing anything else – the change in the horse is our reward". We say thank you, for practical care in this way.

### HORSES FINDING HOMES

Thirty three horses were rehomed, two moving from a 'growing up' home to their permanent home. Thanks to Lisa and Michelle for giving these young horses a good start, and Liz who took on PHHWV Spike to rear. Seven oldies found a home, and eleven ponies.

### PHHWV MEMBER RACHEL

Rachel is the owner of a retail store during the day. "I'm a member because I want to help the horses, and being in a group you have more chance of doing something. I have helped in reeducating and rehoming horses, and floated horses when it's needed locally. I took 3 ponies to handle when PH helped the RSPCA, and found homes locally when they had settled down. I try to find the right person for each horse and keep in touch to see how they are going. I believe in giving back, even when I was young, I met people who helped horses."

PHHWV MEMBER LIZZIE

Lizzie rang PHHWV when she was looking for a young horse, as her mother had been a member from when she was only 6.

"I got Aurelia on the 22 January 2013 from Benalla. She was a pony from a herd rescued at Jeparit. She had some education, but once turned out she went back to her old habits. She was difficult to deal with at first but now we work together. Aurelia has helped me so much, which is why I help others (people & horses). I take people under my wing that have depression. She will love you and if you know what you are doing, Aurelia is the first horse out there. I'm giving back what she has given to me. She is currently being broken in and she's taking it all in her stride. Aurelia and myself are the perfect team together. What more could I ask for.

So thank you to project hope for giving me the chance to have Aurelia. I would take on another PHHWV horse in a heart beat."

### PHHWV MEMBER SUE

I own a TB OTT who I love, but don't ride nearly enough. I have 10 acres, a son who plays sport, we work, and we are forever undertaking property improvements. I support Project Hope because I am a lover of horses. I simply don't have the time to do much but I can take a horse when I have a spare paddock. I love what PH stands for and what it achieves.

I had a few horses here after the fires, and helped feed some others that were poorly. Last year I collected a Shetland found on the roadside (and taken to the pound in the police car). A little man with a big personality - so I called him Elvis. He was an 8 yo stallion with VERY BAD manners to other horses, but fun to take for a walk. I suspected he'd been dumped, as few agistment properties will take stallions. We had him here a while, but no owner came forward. As he couldn't be paddocked with other horses, PHHWV found him a new home.

## "WE'RE HERE FOR THE HORSE" PHHWV members work with horses

### **PHHRV "PERI"**

"Can you help me find agistment?" A country person called, desperate. Not on a good income, she had been using borrowed paddocks for years to care for a 16.2h TB she'd taken from the sales because she felt sorry for him. Maybe in earlier years it worked, but she had run out of options. Her current paddock had been sold. She cycled local areas without success.

PH used its member network. The horse was known, and was not in bad condition. Then the owner found a paddock, but couldn't manage the horse to shift it. Then, as networks do, PH had another call. Others were helping supplementing feed or water when the owner had not appeared. They were frustrated at her varying attendance, and with practical care like a hoof crack not being attended to.

Given these details, Project Hope offered to take 'Peri'. None were more relieved than the owner as she mostly wanted to make sure this horse was OK. Racing Victoria *Off the Track* program floated Peri to his new home.

Since then Peri has enjoyed early retirement in a herd cared for by Phil. His feet are improved and he is looking better than ever.

### PHHWV "AMELDA"

"Stunning" was the first reaction to a little dun pony with a flaxen mane, however, when PHHWV met her, Amelda was 3yo, one of 3 guite unhandled little ponies. All had foundered. Amelda picked up with good care, but then became 'boss'. This was not a good situation for her older carer. So PHHWV member Sharon, who had a little assertive 4 legged one, took on Amelda for strict handling. Amelda learned to respect humans. She took to being led and lunged, and coming when called. She became easier to handle, and later that year, was educated to be a ridden pony. Sharon and her family had bonded with Amelda – but they couldn't keep her. Enter Cherie, and her 3 children. Newly on a farm, they met Amelda on Facebook - but had to wait to get fencing and for Amelda to make the long trip across town. Their first challenge was the founder that had reappeared. Cherie and her family set up a feed and exercise regime, and Amelda met her 3 new small owners. Since then, Amelda has been busier

than ever with her new riders. The founder has been managed and kept at bay. Now she is being prepared for her first pony club outing - We hope a busy future awaits her!

## "WE'RE HERE FOR THE HORSE" PHHWV members work with horses

### THE STORY OF ONE PADDOCK

"There's a skinny TB on XXX road"... a member noticed this and another horse, and so began a six month contact between Project Hope reps and some horse owners under stress. At first, we were met with "We're OK". As months past and the skinny horse remained skinny, we called again, saying it would be difficult to meet horses' feed needs, and care for a family, on a limited budget.

Then a break through - a phone call. "We can't manage, could you take our horse?" The skinny TB moved into PH care. Its mate, not surrendered, moved into a large grassy paddock. Whilst visiting we were asked to see horses owned by others. A mare and young foal worried our reps. The mare was eating bark, the foal was lethargic, our reps felt we had limited time to achieve change. Fortunately, the owners listened. They couldn't easily get to the paddock, and money was given to others for feed that hadn't arrived. Rep Leigh found agistment for them to look at nearer their home; we gave feed for the mare and foal, and asked them to clean the paddock (which they did). Later, PH shifted the mare and foal to agistment chosen by the owners. The chat in this move was fairly clear to the 18yo owner - you keep the feed up to this horse, keep it looking good and cared for, or we will be in touch. The young owner did visit daily, and recently mare and foal were doing OK.

Two other horses needed help. One was a family pet, but was now old and very skinny. The other was a mare that would not come to humans, again underweight, possibly pregnant. The family of the oldie had ill children amongst other stresses. At first they said they would feed it more. Over a month or so they were struggling, but kept in touch. Then, a call to ask PH to take their oldie – it would be better for the horse. Project Hope found a carer who just enjoys giving a home to an old horse. He now has no ribs showing. He knows feed time, and is not backward at rattling his feed bucket!

Rep Kerryn was picking up the oldie – as she passed the paddock of the frightened mare, its head (with halter on) popped over to look. Quickly, she clipped on the lead. Half an hour later, this mare was loaded and on her way to PH care. On the way, a visit to a vet, and pregnancy was ruled out. Living at first in a stable and round yard, she became used to humans. Then loading with little fuss, she went to short-term care to gain weight and find a home as a companion mare.

## PROJECT HOPE HORSE WELFARE VICTORIA TREASURERS REPORT

You will find a fully detailed income and expenditure statement in the attached auditors report for the 2014 / 2015 financial year. In summary the report shows our income as \$ 66,166.92 and our expenses as \$ 66,896.25 resulting in an operating loss for the financial year of \$ 759.77.

Generally income and expenses were in line with budgeted expectations and no extra ordinary income or expense was experienced.

Membership revenue of \$15,780.00 represents a total of 351 new and renewing members, which is in line with our membership base of 378 as at 28<sup>th</sup> February 2015. Membership

revenue at \$15,780.00 represents a 28% increase on the previous financial year. We received financial donations totaling \$34,770.04. This is an increase of 54% on the previous year.

Expenses were in line with the previous financial year so the net effect of increased income and static expenses resulted in a break even position for the year as opposed to a loss the previous year. Financial donations were received from the below individuals, groups and clubs.
