I remember the day my partner and I picked up PHHWV Hercules with his 0.5 Body Condition Score and his lung infection, wondering if we would be able to pull him through, with 2 hourly checks day and night for colic as we started weaning him and his companions PHHWV Miss Mary, PHHWV Sir Fuzzy Bear (blame my 8 year old daughter for that name, though she will vehemently deny it !) and PHHWV Romeo onto food. They all pulled through! PHHWV Miss Mary is now under saddle in a loving forever home! However, PHHWV Romeo sadly later broke his leg.

A huge, heartfelt thank you to the Representatives who visit for the horse reports, our supporters, our volunteers, but most of all I would like to extend my personal thanks to the committee that has kept things moving!

I am very proud to have been a part of this wonderful organisation, and I will continue to for as long as I can but for the moment I need a chance to recharge my batteries - so it is with great pleasure I will hand over the reins to the very capable Minda ...

Secretary's Report

Project Hope currently has 443 members. The number of new memberships for the period March 2016 - February 2017 was 67, compared with 65 the previous year. Treasurer's Report for the financial year 1st March 2016 to 28th February 2017

Attached you will find the formal Financial Tax Review conducted by the accounting firm Krammers Accountants. This Profit & Loss statement and Balance Sheet outline in detail the financial position of the association.

I have also attached a comparison between the 2016 / 2017 financial year and the previous 2015 / 2016 financial year.

In summary:

- Total Income was \$81,830.97.
 - An increase of \$26,665 on the previous financial year.
- Total expenditure was \$72,409.93.
 - A decrease of \$3,487.68 on the financial year.
- Administrative expenses were \$17,227.74
 - A decrease of \$15,332.03 on the previous financial year.
- Horse expenses were \$55,182.19.
 - An increase of \$11,844.15 on the previous financial year.
- Total profit was \$9,421.04.
 - A turnaround of \$30,216.03 on the previous financial year.

Project Hope continues to maintain a strong financial position. As always, this is 100% due to the generosity of our members who provide short term and long term care for our horses utilising their own resources at no cost to the association.

The challenge, from a financial viewpoint, for the coming years is the training and development of the horses taken in from the RSPCA Warak seizure. These horses have challenging needs that in many cases need professional training to bring them to the point where they can be placed into long term care. The cost of this professional training may adversely impact on our cash reserves in the coming years.

Home sweet Homefinder

All of us on Committee have an additional role called a 'Homefinder' which was, until recently for me, something of a mystery. New to our Committee, and not a horse owner (yet), how could I possibly find someone to adopt one of our horses waiting for a home? I didn't have the connections with fellow horse owners so it seemed impossible.

When horses are surrendered to Project Hope, they are initially taken into Short Term Care, where one of our wonderful Project Hope members looks after them until they find their Long Term home. We Homefinders are the bridge between the Short Term Carer, who can report on the horse's immediate needs and its progress, and whoever out there may be looking to adopt one of our horses. We liaise with the Short Term Carer, prising pretty pictures from them so we can show the horses off in an advantageous light (ideally) on our website, in our newsletters, and on facebook.

Putting the 'home' into the Homefinder role, I recently realised it could also be called a Matchmaking service (we could rename 'Horses for Lease' as 'RSVPH') when - after a sneaky process of persuasion - I managed to pair up a 10yo well trained riding horse with a dear friend who lives nearby with multiple animals in her care, including two horses who she loves dearly but cannot ride ... Now she has three horses, who are all getting on very well, and I am so looking forward to joining her on a ride around our home in the bush - once I get my Cupid act together, for my own match made in heaven (or thereabouts).
